ADDITIONAL TERMS AND CONDITIONS OF BOND

Having been charged with multiple offenses of Sections 49.04-49.06 Texas Penal Code or an offense under Section 49.07 or 49.08 of that code, in addition to the \$\_\_\_\_\_ surety bond you will be required to post to secure your release from jail you are Ordered by the Court to comply with the following additional terms and conditions of you bond:

1. The Defendant **shall** within 24 hours after the posting of bond on this case report to Myra Rodriquez (hereinafter referred to as "Supervision Officer") with the Denton County Community Supervision and Corrections Department, 301 E. McKinney St., Denton, Texas 76201-4231 where Defendant shall immediately submit to a complete drug and alcohol testing and pay for the costs of this test within 10 days of giving this specimen.
2. The Defendant is Ordered to pay \$10.00 as a monitoring fee per month until this case has been resolved.
3. Have a device installed, on the motor vehicle owned by the defendant or on the vehicle most regularly driven by the defendant, that uses a deep-lung breath analysis mechanism to make impractical the operation of the motor vehicle if ethyl alcohol is detected in the breath of the operator and that the defendant not operate a motor vehicle until further order of the Court. Have the device installed on or before the 8<sup>th</sup> day after posting bond, and follow recalibration schedules and rules of the monitoring agency and pay all costs incurred;
4. The Defendant shall meet with the Supervision Officer Myra Rodriquez or her designee, (hereinafter referred to as "Supervision Officer") with the Denton County Community Supervision and Corrections Department, 301 E. McKinney St., Denton, Texas 76201-4231 every Tuesday at 8:30 a.m. beginning the Tuesday next after the 8<sup>th</sup> day after posting bond on this warrant until further Order of this Court. Additionally, the Defendant is Ordered to comply will all recommendations of his/her Supervision Officer, including but not limited to, seeking evaluations by other professionals for possible admittance into an in-patient drug rehabilitation facility. Further the Defendant is Ordered to submit to weekly testing for alcohol or illicit drug usage or at any time the Supervision Officer deems necessary and pay for the costs of these tests within 10 days of giving the specimen.
5. The court further orders the Defendant, not to commit an offense against the laws of this State, of any other State, or the United States, and avoid the illegal use or possession of controlled substances and/or marijuana. The Defendant shall also not consume any alcoholic beverages.
6. Further should the Defendant fail to report to the Supervision Officer weekly, fail any drug tests or fail to abide by the recommendations of their Supervision Officer, or fails to

comply with all conditions of this bond the Court may immediately revoke the bond and issue a warrant for the Defendant's arrest.

7. Beginning on or before the 8<sup>th</sup> day after posting bond on this warrant you shall attach a SCRAM ankle monitor (Secure Continuous Remote Alcohol Monitor) for the entire period of community supervision or until released by the court. You are **Ordered** to pay all costs associated with the SCRAM monitor and are **Ordered** not to tamper with, remove or obstruct the monitor. You are further **Ordered** to abide by all rules and requirements required under any participation agreement including not missing any communication times set out by the participant agreement. You are further **Ordered** to allow for the visual inspection of the ankle monitor at the request of your Supervision Officer.
